APPROVAL

- [Brimbank C157](#) and [Melton C143](#) reserve land for the Palmers Road Upgrade Project to widen Robinsons Road, Westwood Drive and Calder Park Drive between the Calder Freeway and the Western Freeway. The amendments exempt the project from planning permit requirements via an incorporated document, apply the Public Acquisition Overlay, and make the Minister for Planning the responsible authority for the project.
- [GC67](#) (Melbourne Metro) replaces the schedules to Clause 52.03, 61.01 and 81.01 of the Maribyrnong, Melbourne, Port Phillip and Stonnington Planning Schemes to insert reference to an amended incorporated document titled the *Melbourne Metro Rail Project Incorporated Document, May 2017* incorporated document).
