Appendix A Terms of Reference



Terms of Reference

Fingerboards Mineral Sands Project Inquiry and Advisory Committee

Version: June 2020

The Fingerboards Mineral Sands Project Inquiry and Advisory Committee (the IAC) is appointed to inquire into, and report on, the proposed Fingerboards Mineral Sands Project (the project) and its environmental effects in accordance with these Terms of Reference.

The IAC is appointed pursuant to:

- section 9(1) of the Environment Effects Act 1978 (EE Act) as an inquiry; and
- part 7, section 151 of the Planning and Environment Act 1987 (P&E Act) as an advisory committee.

The IAC will provide advice that can be used to inform the Environment Protection Authority's (EPA) consideration of the works approval application (WAA) prepared by the proponent for the project.

Name

The IAC is to be known as the 'Fingerboards Mineral Sands Project Inquiry and Advisory Committee'.

Skills

- 2. The IAC members should have following expertise:
 - a. groundwater and surface water;
 - b. biodiversity and ecology;
 - c. rehabilitation of mineral sands mines, soils and erosion;
 - d. air quality; and
 - e. statutory planning.
- Where it considers it necessary, the IAC may seek additional specialist expert advice¹ to assist it in undertaking its role, in particular with respect to:
 - a. noise and related impacts on amenity;
 - b. agriculture and rural land use;
 - c. landscape and visual impacts; and
 - d. social impact assessment.
- 4. The IAC will comprise an appointed Chair (IAC Chair), a Deputy Chair and other members.

Purpose of the IAC

- The IAC is appointed by the Minister for Planning under section 9(1) of the EE Act to hold an inquiry into the environmental effects of the project. The IAC is to:
 - review and consider the environment effects statement (EES), public submissions received in relation to the environmental effects of the project and the reports and advice from the appointed Department of Environment, Land, Water and Planning (DELWP) independent peer reviewers;
 - consider and report on the potential environmental effects of the project, their significance and acceptability, and in doing so have regard to the draft evaluation objectives in the EES scoping requirements and relevant policy and legislation;
 - identify any measures it considers necessary and effective to avoid, mitigate or manage the environmental effects of the project within acceptable limits, including any necessary project modifications;

¹ The IAC may also direct questions to the independent peer reviewers appointed by the Department, Environment, Land, Water and Planning (DELWP) for the water, air quality and rehabilitation technical studies.



- advise on how this relates to relevant conditions, controls and requirements that could form part
 of the necessary approvals and consent for the project;
- report its findings and recommendations to the Minister for Planning to inform his assessment under the EE Act; and
- f. review the works approval application and relevant submissions and provide advice that can be used to inform the EPA's consideration of the WAA prepared by the proponent for the project.
- 6. The IAC is appointed as an advisory committee under section 151 of the P&E Act to:
 - a. review draft planning scheme amendment (PSA) C156EGIP, which have been prepared to facilitate the project, along with any public submissions received in relation to the draft PSA;
 - provide a report to the Minister for Planning as to whether the draft PSA contains provisions and controls that are appropriate for the project; and
 - c. recommend any changes to the draft PSA that it considers necessary.

Background

Project outline

- 7. The project proposes to develop the Fingerboards Mineral Sands Project which has an approximate area of 1,875 hectares and is located approximately 20 kilometres north-west of Bairnsdale in East Gippsland, Victoria. The proposed mining methods involve open pit mining to extract approximately 170 million tonnes (Mt) of ore over a projected mine life of 20 years to produce approximately 8 Mt of mineral concentrate. Mine products are proposed to be transported via road or by rail for export overseas. The project includes the following elements:
 - a. the development of a mineral sands mine;
 - b. two mining unit plants;
 - wet concentrator plant (comprising mineral separation processing and tailings thickening and disposal plant);
 - d. water supply infrastructure;
 - tailings storage facility;
 - additional site facilities, such as a site office, warehouse, workshop, loading facilities and fuel storage.
- The project's proponent is Kalbar Operations Pty. Ltd, who is responsible for preparing technical studies, consulting with the public and stakeholders and preparing an EES.

EES assessment process

- In response to a referral under the EE Act from the proponent, the Minister for Planning determined on 18 December 2016 that an EES is required for the project and issued his decision with procedures and requirements for the preparation of the EES as specified in Attachment 1.
- The EES has been prepared by the proponent in response to the EES scoping requirements issued by the Minister for Planning in April 2018.
- The EES will be placed on public exhibition for forty (40) business days, together with the WAA and draft PSA. DELWP will be responsible for giving notice.
- DELWP must liaise with the office of Planning Panels Victoria (PPV) to agree on the Directions Hearing and Hearing dates, which are to be included on all notices.

Commonwealth assessment process

13. Because of its potential impacts on matters of national environmental significance, the project was determined to be a controlled action for the purposes of the Environment Protection and Biodiversity Conservation Act 1999 (Cth) (EPBC Act) on 6 July 2017. The relevant controlling provisions under the EPBC Act relate to Ramsar wetlands (sections 16 and 17B); listed threatened species and communities

- (sections 18 and 18A); listed migratory species (sections 20 and 20A); and nuclear actions (section 21 and 22A).
- 14. Under the bilateral agreement between the Australian and Victorian Governments, the Victorian EES process is serving as the accredited process for the assessment purposes of the EPBC Act. The assessment of environmental effects to be made by the Victorian Minister for Planning will be provided to the Commonwealth Minister for the Environment to inform the approvals decision under the EPBC Act. To assist the Minister in making his assessment, the IAC should specifically identify its advice relevant to matters of national environmental significance that may be affected respectively by the project.

Planning approval process

15. The IAC is to consider and provide advice on draft PSA C156egip that proposes planning controls and provisions for the various works and activities outside of the mining licence area. The PSA, in conjunction with other required approvals will regulate the use and development of the project in accordance with an incorporated document which is proposed to be included in the East Gippsland Planning Scheme.

Works approval process

- 16. A WAA for the project has been prepared in accordance with the provisions of the Environment Protection Act 1970 (EP Act). The works approval application will be jointly advertised with the EES, in accordance with section 20AA of the EP Act.
- 17. Section 19B(3)(b) of the EP Act provides that: if an application for a works approval is to be jointly advertised under section 20AA with a notice relating to the same proposal under the Environment Effects Act 1978... comments by any person or body interested in the application must be made as a submission on the environment effects statement or be included in any submission on the environment effects statement. In addition, the EPA can no longer decide under section 19B(6) to hold a section 20B conference.
- 18. The IAC is to provide advice that can be used to inform the EPA's consideration of the WAA prepared by the proponent. The IAC may request any further information from the proponent that it considers necessary to assist it to provide that advice. The advice should recommend avoidance, mitigation or management measures that the IAC considers are necessary to ensure compliance with any relevant legislation and/or policy.

Other approvals

- The project may require several other statutory approvals and/or consents, as outlined in the EES, including:
 - a. a mining licence and approved work plan under the Mineral Resources (Sustainable Development) Act 1990 (MRSD Act);
 - approval under the EPBC Act;
 - approved Cultural Heritage Management Plans under the Aboriginal Heritage Act 2006 to manage works in areas of cultural heritage sensitivity;
 - d. approvals under the Water Act 1989 for extraction of surface and/or groundwater,
 - e. approvals under the Radiation Act 2005
 - f. a permit to remove listed flora and fauna under the Flora and Fauna Guarantee Act 1988;
 - g. an authority to take or disturb wildlife under the Wildlife Act 1975; and
 - h. consents for works on, over or under waterways under the Water Act 1989.

Process

Stage 1 – Submissions

- 20. Submissions on the EES, draft PSA and WAA will be collected by PPV in accordance with the 'Guide to Privacy at PPV through the Engage Victoria Website. All written submissions or other supporting documentation should be published on-line, unless submitters request that their submission not be publicly available, or where the IAC specifically directs that the submission or part of it is to remain confidential.
- Electronic copies of submissions on the EES, draft PSA and WAA should be provided to the proponent, East Gippsland Shire Council, Wellington Shire Council, the DELWP and EPA.
- Petitions will be treated as a single submission, and only the first name to appear on the first page of the submission should receive correspondence in relation to the IAC.
- Any written material or evidence provided to the IAC during the public hearing should be published online, unless the IAC specifically directs that the material is to remain confidential.
- 24. PPV will retain any written submissions and other documentation provided to the IAC for a period of five years after the time of the appointment of the IAC.

Stage 2 – Public hearing

- The IAC must hold a public hearing and may make other such enquiries as are relevant to undertaking its role.
- When it conducts a public hearing, the IAC has all the powers of an advisory committee that are specified in section 152(2) of the P&E Act.
- Prior to the commencement of the public hearing, the IAC must hold a directions hearing in order to
 make any directions it considers necessary or appropriate as to the conduct, scope or scheduling of the
 public hearing.
- 28. The IAC may inform itself in any way it sees fit, but must review and consider:
 - a. the exhibited EES, draft PSA and WAA;
 - all public submissions, and all submissions and evidence provided to the IAC by the proponent, state agencies, local councils and the public;
 - c. the reports and advice of three independent peer reviewers appointed by DELWP;
 - d. any information provided by the proponent that responds to submissions; and
 - e. any other relevant information that is provided to, or obtained by, the IAC.
- 29. The IAC must conduct its public hearing in accordance with the following principles:
 - a. the public hearing will be conducted in an open, orderly and equitable manner, in accordance with the principles of natural justice, with a minimum of formality and without legal representation being necessary for parties to be effective participants; and
 - the IAC process is to be exploratory and constructive with adversarial behaviour minimised and with cross-examination controlled by the IAC Chair.
- 30. The IAC may limit the time of parties appearing before it.
- 31. The IAC may conduct a public hearing when there is a quorum of at least two of its members present or participating through electronic means in line with Attachment 2, one of whom must be the IAC Chair or Deputy Chair. If the IAC is made up of four members then a quorum of at least three of its members is required.
- 32. Recording of the hearing must be undertaken by the proponent if as directed by the IAC Chair. If the hearing is recorded, the audio recording will be provided to PPV as a weblink and would be made

publicly available as soon as practicable after the conclusion of each day of the hearing, or otherwise as directed by the IAC Chair.

33. Any other audio or video recording of the hearing by any other person or organisation may only occur with the prior consent of, and strictly in accordance with, the directions of the IAC Chair.

Stage 3 - Report

- 34. The IAC must produce a written report for the Minister for Planning containing the IAC's:
 - a. conclusions with respect to the environmental effects of the project and their significance and acceptability;
 - findings on whether acceptable environmental outcomes can be achieved, having regard to legislation, policy, best practice, and the principles and objectives of ecologically sustainable development;
 - c. recommendations and/or specific measures that it considers necessary and appropriate to prevent, mitigate or offset adverse environmental effects to acceptable environmental outcomes, having regard to legislation, policy, best practice, and the principles and objectives of ecologically sustainable development;
 - d. recommendations as to any feasible modifications to the project (e.g. extent, design, alternative configurations, or environmental management) that would enable more appropriate environmental outcomes;
 - recommendations for any appropriate conditions that may be lawfully imposed on any approval
 for the project, including with respect to the content of the draft work plan or conditions that might
 appropriately be attached to approval of a work plan if issued under the MRSD Act;
 - f. recommendation on changes, including to the structure and content, that should be made to the draft PSA in order to ensure that the environmental effects of the project are acceptable having regard to legislation, policy, best practice, and the principles and objectives of ecologically sustainable development;
 - g. recommendations as to the structure and content of the proposed environmental management framework, including with respect to monitoring of environmental effects, contingency plans and site rehabilitation:
 - recommendations with respect to the WAA, including recommendations about conditions that might appropriately be attached to a works approval if issued; and
 - specific findings and recommendations about the predicted impacts and residual risks for matters of national environmental significance and their acceptability, including appropriate controls and environmental management.
- 35. The report should include:
 - a. information and analysis in support of the IAC's findings and recommendations;
 - b. a list of all recommendations, including cross-references to relevant discussions in the report;
 - a description of the public hearing conducted by the IAC, and a list of those persons consulted with or heard by the IAC;
 - d. a list of all submitters in response to the exhibited EES; and
 - e. a list of the documents tabled during the public hearing.

Timing

- The IAC should commence its main public hearing no later than 40 business days from the final date of the exhibition period, or as otherwise agreed by the Minister for Planning.
- The IAC must submit its report in writing to the Minister for Planning within 40 business days from its last hearing date.

Minister's assessment

- The Minister for Planning will make his assessment of the environmental effects of the project after considering the IAC's report as well as the EES, submissions and any other relevant matters.
- 39. PPV will notify submitters of the release of the Minister for Planning's assessment and IAC report.

Fee

- 40. The fees for the members of the IAC will be set at the current rate for a panel appointed under part 8 of the P&E Act.
- 41. All costs of the IAC, including the costs of obtaining any expert advice, technical administration and legal support, venue hire, accommodation, recording proceedings and other costs must be met by the proponent.

Miscellaneous

- The IAC may apply to the Minister for Planning to vary these terms of reference in writing, at any time prior to submission of its report.
- 43. The IAC may retain legal counsel to assist it in undertaking its role.
- 44. PPV is to provide any necessary administrative support to the IAC.
- 45. The IAC may engage additional technical and administrative support or as required direct questions to the independent peer reviewers appointed by DELWP.

Attachment 1

DECISION ON PROJECT: Fingerboards Mineral Sands Project

Decision under section 8B(3)(a) of the Environment Effects Act 1978

Assessment through an Environment Effects Statement (EES) under the *Environment Effects Act* 1978 is required for the reasons set out in the attached Reasons for Decision.

Procedures and requirements under section 8B(5) of the Environment Effects Act 1978

The procedures and requirements applying to the EES process, in accordance with both section 8B(5) and the *Ministerial guidelines* for assessment of environmental effects under the Environment Effects Act 1978 (Ministerial Guidelines), are as follows:

- (i) The EES is to document the investigation and avoidance of potential environmental effects of the proposed project, including for any relevant alternatives (such as for the mining extent, methods for mining and processing, water supply and transport of mining outputs), as well as associated environmental mitigation and management measures. In particular the EES should address:
 - a. Effects on biodiversity and ecological values within and near the site, and associated with adjacent road reserves and riparlan areas, including: native vegetation; listed threatened ecological communities and species of flora and fauna; and other habitats values:
 - Effects on surface water environments, including downstream wetlands, and groundwater resources (hydrology, quality, uses and dependent ecosystems);
 - Effects on the land uses and landscape values of the site and surrounding areas, including the implications for agricultural productivity and nearby Crown land, such as the Mitchell River National Park;
 - Effects on land stability, erosion and soil productivity associated with the construction and operation of the project, including rehabilitation works;
 - Effects on Aboriginal and non-Aboriginal cultural heritage values;
 - Effects of project construction and operation on air quality and noise on nearby sensitive receptors (in particular residences);
 - Both positive and adverse socio-economic effects, at local and regional scales, potentially generated by the project, including indirect effects of the project construction workforce on the capacity of local community infrastructure; and
 - Solid and liquid waste that might be generated by the project during construction and operation.
- (ii) The matters to be investigated and documented in the EES will be set out in detail in scoping requirements prepared by the Department of Environment, Land, Water and Planning (the department). Draft scoping requirements will be exhibited for 15 business days for public comment, before being finalised and then issued by the Minister for Planning.
- (iii) The level of detail of investigation for the EES studies should be consistent with the scoping requirements issued for this project and be adequate to inform an assessment of the potential environmental effects (and their acceptability) of the project and any relevant alternatives, in the context of the Ministerial Guidelines.
- (iv) The proponent is to prepare and submit to the department a draft EES study program to inform the proparation of scoping requirements.
- (v) The department is to convene an inter-agency Technical Reference Group (TRG) to advise the proponent and the department, as appropriate, on scoping and adequacy of the EES studies during the preparation of the EES, as well as coordination with statutory approval processes.
- (vi) The proponent is to prepare and submit to the department its' proposed EES Consultation Plan for consulting the public and engaging with stakeholders during the preparation of the EES.

- Once completed to the satisfaction of the department, the EES Consultation Plan is to be implemented by the proponent, having regard to advice from the department and the TRG.
- (vii) The proponent is also to prepare and submit to the department its proposed schedule for the studies, preparation and exhibition of the EES, following confirmation of draft accoping requirements. This is to enable effective management of the EES process on the basis of an agreed alignment of the proponent's and department's schedules, including for TRG review of technical investigations and the EES documentation.
- (viii) The proponent is to apply appropriate peer review and quality management procedures to enable the completion of EES studies and documentation to a acceptable standard.
- (ix) The EES is to be exhibited for a period of 30 business days for public comment, unless the exhibition period spans the Christmas-New Year period, in which case 40 business days will apply.
- (x) An inquiry will be appointed under the Environment Effects Act 1978 to consider and report on the environmental effects of the proposal.

PROJECT NAME: FINGERBOARDS MINERAL SANDS PROJECT

Amended procedures and requirements under section 8B(5) of the Environment Effects Act 1978.

Under the declared state of emergency in response to the coronavirus pandemic, conventional exhibition of environment effects statements (EES) is not possible. Physical display of printed copies of the EES in public places cannot occur. Similarly, arrangements with respect to formal hearings of inquiries under the Environment Effects Act will also differ, if restrictions are still in force at the time of an inquiry.

Accordingly, the procedures and requirements applying to the EES, issued on 18 December 2016 in accordance with section 8B(5) of the Act and the Ministerial guidelines for assessment of environmental effects under the Environment Effects Act 1978, are amended as follows.

- (a) The EES is to be exhibited for a period of 40 business days for public comment, or such other period as the Minister may subsequently direct in writing.
- (b) No less than two weeks before the first day of the public exhibition period, the proponent must place notices in newspapers and on-line, as well as communicate with known interested parties, to:
 - foreshadow the intention to commence formal exhibition;
 - note the impossibility of providing exhibition copies for physical inspection at public exhibition places;
 - describe intended on-line availability of the EES and related documentation for exhibition purposes; and
 - invite any potential submitters to register to receive EES documents on USB, or other electronic media, and for those who may have accessibility issues or, where electronic options are impracticable, in hard copy.
- (c) Where hard copy documents are reasonably requested, the proponent must provide hard copies of:
 - the EES summary document and mapbook free of charge, and the EES Main Report for a modest charge aligned with postage costs, unless instructed otherwise by the Department of Environment, Land, Water and Planning's (DELWP) Director Impact Assessment;
 - other EES attachments or EES technical appendices, subject to payment of an appropriate fee, having regard to costs of printing and postage and the circumstances of the request, unless instructed otherwise by DELWP's Director Impact Assessment; and
 - the Environment Protection Act 1970 works approval application, unless instructed otherwise by the Environment Protection Authority.

- (d) The proponent must dispatch requested electronic media and hard copies to registered addresses within a week of receipt of each registration (and payment, where relevant) or in time for the commencement of the exhibition period, whichever is the later.
- (e) The inquiry that I will appoint under the Environment Effects Act, subject to the approval of the Governor in Council, to consider the environmental effects of the proposal is to be conducted by formal hearing in the most practicable manner available under the prevailing circumstances. That might, if necessary, include the use of video conferencing or other comparable technology.
- (f) The proponent must arrange for recordings to be made of formal hearings of the inquiry, whether held conventionally or remotely, subject to any directions from the inquiry chair, and must cause recordings to be posted on-line as quickly as practicable. The proponent must post links to the recordings on its project website as soon as practicable after each day of hearings. DELWP must post links to the recordings on its relevant web pages as soon as practicable after each day of hearings.

1. INTRODUCTION

- 1.1. This document is an Incorporated Document in the East Gippsland Planning Scheme (Planning Scheme) pursuant to section 6(2)(j) of the Planning and Environment Act 1987 (Vic).
- 1.2. This Incorporated Document facilitates the delivery of certain infrastructure (the **Project Infrastructure**) required to support the Fingerboards Mineral Sands Project (the **Project**) on land outside the area to which mining licence [xxx] applies. The area to which mining licence [xxx] applies is referred to as the **Project Area**.
- 1.3. This document facilitates the Project, by providing a specific control for the purpose of Clause 45.12 of the planning scheme in respect of the use and development of land other than the Project Area for the purpose of the Project Infrastructure.

2. MEANING OF 'RESPONSIBLE ROAD AUTHORITY'

2.1. Responsible Road Authority has the meaning provided in s 37 of the *Road Management Act* 2004 (Vic).

3. PURPOSE

3.1. The purpose of the control in clause 5 is to permit and facilitate the use and development of the land described in clause 4 for the purposes of the Project Infrastructure as defined in clause 1.2.

4. LAND TO WHICH THIS DOCUMENT APPLIES

4.1. The control contained in clause 5 applies to land affected by Specific Controls Overlay – Schedule 1 (SCO1) as shown on the planning scheme maps in the East Gippsland Planning Scheme (the Infrastructure Area).

5. CONTROL

- 5.1. Despite any provision to the contrary or any inconsistent provision of the Planning Scheme, no planning permit is required for, and no provision in the Planning Scheme operates to prohibit, restrict or regulate, the use and development of the Infrastructure Area for the purposes of the Project Infrastructure.
- 5.2. The Project Infrastructure consists of:
 - 5.2.1. Water pipeline and overhead 22kV powerline over private land to a new pumping station on the Mitchell River;
 - 5.2.2. Water pipeline and associated bore pumps within the part of the Infrastructure Area to the south-east of the Project Area;

- 5.2.3. Any buildings or works required to implement the Mitigation Measures generally in accordance with the Minister's Assessment of the Project dated [date] made pursuant to the *Environment Effects Act 1978* or the requirements of any plan required by this control (other than the removal of native vegetation);
- 5.2.4. Construction of a private new road adjacent to Chettles Road, continuing south-east over private land to the new railway siding;
- 5.2.5. New 66kV and 22kV powerlines adjacent to the new road referred to in clause 5.2.4;
- 5.2.6. A new water pipeline adjacent to the new road referred to in clause 5.2.4;
- 5.2.7. Noise bunding including earthworks along sections of the new road referred in clause 5.2.4 above;
- 5.2.8. A rail siding (one of two options) adjacent to the Bairnsdale railway line;
- 5.2.9. Road diversions, road widenings and roadworks including intersection upgrades (local and Road Zone Category 1);
- 5.2.10. Any temporary construction works offices and associated car parking;
- 5.2.11. Vegetation removal associated with any of the above in accordance with the Native Vegetation Management Plan approved in accordance with clause 6.8.1 and all approvals; and
- 5.2.12. Infrastructure that is incidental, or ancillary, to the infrastructure referred to in the above paragraphs.
- 5.3. The use and development of the Infrastructure Area for Accommodation or Food and Drink Premises is prohibited, whether or not ancillary to another use of land.
- 5.4. The control in this Incorporated Document does not apply to the use and development of the Infrastructure Area for any purpose other than for the purposes of the Project Infrastructure. Use and development of the Infrastructure Area for any other purpose must be in accordance with the Planning Scheme.
- 5.5. For the avoidance of doubt, nothing in this control authorises the creation, variation, or acquisition of any interest in land other than in accordance with the Planning Scheme.

6. CONDITIONS

6.1. The use and development authorised by this Incorporated Document is subject to the conditions set out below.

6.2. Environment Management Framework

- 6.2.1. Prior to the commencement of the use and development of the Infrastructure Area, an Environmental Management Framework (**EMF**) must be prepared in consultation with the responsible authority, the Head of the Department of State Development, Business and Innovation, the Head of Transport for Victoria, the Environment Protection Authority and Southern Rural Water, to the satisfaction of the Minister for Planning.
- 6.2.2. The EMF must include mitigation measures (the **Mitigation Measures**) generally in accordance with the Minister's Assessment dated [date] made pursuant to the *Environment Effects Act 1978*. The Mitigation Measures must address the following areas:
 - (a) Agriculture and horticulture;
 - (b) Air quality;
 - (c) Cultural heritage;
 - (d) Geotechnical:
 - (e) Greenhouse gas;
 - (f) Ground water;
 - (g) Land use and planning;
 - (h) Noise and vibration;
 - (i) Radiation;
 - (j) Socioeconomic impacts;
 - (k) Surface water;
 - (I) Traffic and Transport;
 - (m) Biodiversity;
 - (n) Visual and landscape; and
 - (o) Any other matter identified by the Minister in the Minister's Assessment.

6.2.3. The EMF must

(a) include processes (including for approvals) and timing for the development of the Development Plan, the Construction Management Plan, the Construction Noise Management Plan, the Operation Noise Management Plan, the Traffic and Transport Management Plan, the Native Vegetation Management Plan, the Fire and Emergency Management Plan, the Decommissioning Plan and any other plans or procedures required by the Mitigation Measures as relevant

- to any stage of the development of the Infrastructure Area, including the process and timing for consultation with any person or body with who consultation is required under this Incorporated Document (including under any plan required by this Document or a mitigation measure in a plan); and
- (b) provide for the requirements of any development licence and operating licence issued by the EPA which applies to the Project Infrastructure in the Infrastructure Area (if any).
- 6.2.4. The EMF may be amended from time to time to the satisfaction of the Minister for Planning. An application for approval of an amendment to the EMF must be accompanied by:
 - (a) A 'track changes' version with a schedule explaining the proposed amendment/s and the reason for the proposed amendment/s;
 - (b) A description of the form and extent of any consultation undertaken concerning the proposed amendment/s with relevant councils, relevant government agencies and other stakeholders including community groups and directly impacted landowners; and
 - (c) Any written comments from relevant councils, relevant government agencies and other stakeholders, including community groups and directly impacted landholders.
- 6.2.5. The use and development of the Infrastructure Area must be carried out in accordance with the EMF, including the Mitigation Measures and all plans and procedures required by the Mitigation Measures, and with all plans required by this Incorporated Document.
- 6.2.6. Any other plan required by this Incorporated Document must be consistent with, and give effect to, the EMF including the Mitigation Measures, and be generally in accordance with any development licence and operating licence issued by the EPA which applies to the Infrastructure Area.

6.3. Master Plan

- 6.3.1. Prior to the commencement of any use or development, including any use or development of the Project Area, a Master Plan in respect of the use and development of the Infrastructure Area must be prepared and approved to the satisfaction of the responsible authority.
- 6.3.2. The Master Plan may be amended to the satisfaction of the responsible authority.
- 6.3.3. The Master Plan must be prepared having regard to each of the plans required by this control, and must show as a minimum:

- (a) The location of buildings, works, roads and proposed activities within the Infrastructure Area;
- (b) Areas of vegetation proposed to be removed and retained.

6.4. Development Plan

- 6.4.1. Prior to the commencement of use and development of the Infrastructure Area, a Development Plan must be prepared in consultation with any relevant Responsible Road Authority and approved to the satisfaction of the responsible authority and, in respect to traffic and transport matters, the Head Transport for Victoria.
- 6.4.2. Subject to the prior written consent of the relevant approval authority(s), the Development Plan may be prepared and approved in stages or in respect of any of the element of the Project Infrastructure listed in clause 5.2, but the Development Plan for each stage or element must be approved before the commencement of development for that stage or element.
- 6.4.3. The Development Plan may be amended to the satisfaction of the responsible authority and, in respect to traffic and transport matters, the Head, Transport for Victoria.
- 6.4.4. The Development Plan must show:
 - (a) The location of all buildings, works and proposed activities (including road and rail works) within the Infrastructure Area to be developed or carried out over the life of the Project;
 - (b) If the Development Plan is to be approved in stages or in respect of individual elements of the Project Infrastructure, a plan for each stage of development or element of infrastructure for which approval is currently being sought;
 - (c) Elevations of buildings and above ground proposed works; and
 - (d) All vegetation to be removed, which must be consistent with the Native Vegetation Management Plan approved in accordance with clause 6.8.1.
- 6.4.5. The use or development as shown on the Development Plan must not be altered without the written consent of the responsible authority and, in respect to traffic and transport matters, the Head, Transport for Victoria.
- 6.4.6. The Development Plan must be generally consistent with the approved Master Plan.

6.5. Traffic and Transport Management Plan

6.5.1. Prior to the commencement of use and development, a Traffic and Transport

Management Plan (TTMP) must be prepared by a suitably qualified traffic engineer in

- consultation with East Gippsland Shire Council, and Country Fire Authority, Rural Ambulance Victoria, and Victoria Police, to the satisfaction of the responsible authority and the Head, Transport for Victoria.
- 6.5.2. The TTMP may be amended from time to time to the satisfaction of the responsible authority and the Head, Transport for Victoria.
- 6.5.3. The TTMP must address all elements of the Project Infrastructure and must have regard to the use and development of the Project Area as relevant.
- 6.5.4. Subject to the prior written consent of the responsible authority and the Head, Transport for Victoria, the TTMP may be prepared in stages or in respect of any of the elements of Project Infrastructure listed in clause 5.2, but the TTMP for any stage of development or component must be approved before the commencement of development for that stage.
- 6.5.5. The TTMP must include, as appropriate:

Road and rail works for construction and operation

- (a) Identification and specification of:
 - (i) all proposed works, land and processes required to facilitate the transportation of materials required for the Project (including during construction) to the Project Area;
 - (ii) all proposed works, land and processes required to facilitate the transportation of product from the Project Area to the relevant Victorian Port:
 - (iii) all proposed permanent and temporary roadworks (including intersections and related infrastructure) required to facilitate traffic movements associated with the Project, including construction activity; and
 - (iv) the routes that will be used by trucks associated with the Project and how the use of the roads will be managed.
- (b) A functional layout plan(s) for all new road works (including intersections and related infrastructure) in the Infrastructure Area that identifies who is the Responsible Road Authority for each of the new road works.
- (c) An existing conditions road pavement and road infrastructure survey and regular monitoring program, conducted by an independent engineer, prequalified by the Head, Transport for Victoria, for the roads and road infrastructure to be used by Project traffic in the Infrastructure Area.

- (d) The functional design of all areas for parking and storage of vehicles and machinery.
- (e) A staging plan for implementation of any identified works, land and processes for the road and rail works associated with the Project.

Traffic impacts

- (f) Identification of potential traffic impacts from the proposed road and rail works and Project traffic (including impacts during peak holiday seasons and long weekends), and measures to mitigate and manage these impacts.
- (g) Identification and assessment of the road and associated infrastructure at risk from damage, deterioration or dilapidation arising from the construction and operation of the Project.
- (h) Measures to be taken to manage traffic impacts associated with construction, operation and rehabilitation of the Project on surrounding roads, including consultation with all agricultural landholders within a minimum of 5 km of the Project Area to understand where, when and how the local road network is used for the transport of machinery and stock, and strategies to reduce impacts of traffic associated with the Project and Project Infrastructure on the use of the local road network by regular users including agricultural users and public transport (including school buses) users.

Inspection

- (i) A program of regular inspection works to be carried out during construction, operation, and rehabilitation / decommissioning of the Project and Project Infrastructure to identify road safety hazards or maintenance works necessary as a result of Project-related traffic. Inspections must include traffic counts prior to commencement and annually to identify increases in traffic (including during peak holiday seasons and long weekends) identified by type of vehicle and must be undertaken to the satisfaction of the responsible authority and the Head, Transport for Victoria.
- (j) A program to remediate existing roads and road infrastructure during construction and operation of the Project where remediation is required as a result of Project-related traffic, which identifies who is the Responsible Road Authority for each existing road and item of road infrastructure.

Road Safety Audits

(k) Prior to the commencement of any road or rail works in the Infrastructure

Area, Road Safety Audits conducted by an independent road safety auditor,

pre-qualified by the Head, Transport for Victoria, in accordance with

Austroads – Road Safety Audit for all proposed roads and intersections in the Infrastructure Area in accordance with the approved functional layout plans.

Road and rail works contractor(s)

(I) A requirement that the contractor(s) engaged to undertake the road and rail works in the Infrastructure Area are approved by the Head, Transport for Victoria.

Decommissioning Traffic Management Plan

- (m) A Decommissioning Traffic Management Plan (**DTMP**), which must contain the following:
 - (i) A plan that shows the roads and transport infrastructure covered by the DTMP and identifies who is the Responsible Road Authority for all roads and transport infrastructure.
 - (ii) Specification of:
 - a. the temporary roads and road infrastructure that are to be removed and the condition for reinstatement of the land; and
 - b. the roads and road infrastructure to be retained and any relevant pavement handback criteria;

(iii) A process for:

- a. obtaining an existing conditions road pavement and road infrastructure audit conducted by an independent engineer, prequalified by the Head, Transport for Victoria, for the roads and road infrastructure in the Infrastructure Area that identifies any works required to ensure that any damage to road pavement and road infrastructure caused by the Project is rectified; and
- Implementation of any recommendations of the existing conditions road pavement and road infrastructure survey required by clause 6.5.5(m)(iii)a.
- (iv) A requirement that any remedial works required for permanent roads and road infrastructure required for the roads and road infrastructure to meet relevant standards to the satisfaction of the Head, Transport Victoria.

Agreement

(n) Prior to the commencement of any roadworks in the Project Area and Infrastructure Area, agreement(s) must be entered into with the responsible authority and the Head, Transport for Victoria in relation to any roads, road infrastructure or any rail siding within the Project Area and Infrastructure Area that they are responsible for. The agreement(s) must provide for the following:

- (a) Road and rail works required for construction and operation of the Project
- (i) The provision to each relevant Responsible Road Authority of a bond or bank guarantee, for the purpose of securing satisfactory completion of the road and rail works and any associated remediation works in the Project Area and Infrastructure Area that are the responsibility of that Responsible Road Authority.
- (ii) The bond or bank guarantee (or any replacement bond or bank guarantee) required by clause 6.5.5(n)(i) must be equivalent to the estimated, indexed cost of the relevant road and rail works as agreed by the relevant Responsible Road Authority and must be in place until those works have been completed to the satisfaction of that Responsible Road Authority.
- (iii) An indemnity in favour of the responsible authority against loss or damage reasonably incurred or suffered by the responsible authority in connection with the intersection of a private road constructed and operated for the purpose of the Project with a road or asset of the responsible authority.

Implementation of the DTMP

- (iv) Unless otherwise agreed in writing by the responsible authority and the Head, Transport for Victoria, within 12 months of the cessation of the use of road and rail works in the Infrastructure Area, the approved DTMP required by clause 6.5.5(m) must be implemented, and any other necessary remedial works required for permanent roads to meet relevant standards carried out, at no cost to, and to the satisfaction of, the responsible authority and the Head, Transport Victoria.
- (v) An estimate of the cost of the works required to be undertaken in the approved DTMP must be prepared by a suitably qualified engineer and/or quantity surveyor, to the satisfaction of the responsible authority and the Head, Transport Victoria.
- (vi) The provision to each relevant Responsible Road Authority of a bond or bank guarantee, for the purpose of securing satisfactory completion of the works required by the approved DTMP that relate to infrastructure that is the responsibility of that Responsible Road Authority.
- (vii) The bank guarantee or bond required by clause 6.5.5(n)(vi) must be for the amount calculated in accordance with clause 6.5.5(n)(v) for the relevant works, plus a 20% contingency, with the amount indexed in accordance with any index to the satisfaction of the Head, Transport for Victoria on 1 July

each year, and the bank guarantee or bond maintained at the indexed amount. The bond or bank guarantee (or any replacement bond or bank guarantee) must be in place for a sufficient time to ensure that the works required by the approved DTMP are completed to the satisfaction of the relevant Responsible Road Authority.

- (viii) The relevant Responsible Road Authority may call upon the bank guarantee or bond provided under clauses 6.5.5(n)(vi) in the event of default under clause 6.5.5(n)(iv) to the extent required to remedy the default, and may arrange for the works referred to in 6.5.5(n)(iv) to be undertaken by the relevant Responsible Road Authority or on its behalf.
- (ix) Payment of all reasonable costs and expenses incurred by the responsible authority and the Head, Transport for Victoria for the preparation, execution and review of the agreement(s).
- 6.5.6. The approved TTMP must be implemented to the satisfaction of and at no cost to the responsible authority and the Head, Transport for Victoria.

6.6. Noise Management Plans

- 6.6.1. Prior to the commencement of:
 - (a) construction of the Project Infrastructure, a Construction Noise Management Plan (CNMP) must be prepared generally in accordance with Chapter 4 of EPA Publication 1834 (Civil construction, building and demolition guide) to the satisfaction of the responsible authority in consultation with the EPA; and
 - (b) operation of the Project Infrastructure, an Operational Noise Management Plan (**ONMP**) must be prepared in accordance with the *Environment Protection Act 2017*, including EPA Publication 1826.4 (Noise limit and assessment protocol for the control of noise from commercial, industrial and trade premises and entertainment venues) to the satisfaction of the responsibility authority, in consultation with of the EPA.
- 6.6.2. The CNMP and ONMP may be amended from time to time to the satisfaction of the responsible authority in consultation with the EPA.
- 6.6.3. Each plan must address all elements of the Project Infrastructure as relevant and must have regard to any cumulative noise impact associated with use and development of the Project Area during the relevant stage. The plans must include, but not be limited to:
 - (a) Performance requirements, including maximum noise limits for the Project Infrastructure in accordance with the *Environment Protection Act 2017*;
 - (b) A noise compliance procedure;

- (c) A noise complaints evaluation procedure;
- (d) A noise complaints response procedure;
- (e) Measures that are generally consistent with the requirements set out in the Mitigation Measures;
- A procedure for regularly assessing noise associated with the construction or operation of the Project Infrastructure (as relevant); and
- (g) Measures to minimise risks of harm to human health and the environment so far as reasonably practicable.

6.7. Construction Management Plan

- 6.7.1. Prior to commencement of use and development of any element of Project Infrastructure listed in clause 5.2, a Construction Management Plan must be prepared, in consultation with the EPA and to the satisfaction of and be approved by the responsible authority.
- 6.7.2. The Construction Management Plan may be amended from time to time to the satisfaction of the responsible authority.
- 6.7.3. The Construction Management Plan must include, but not be limited to:
 - (a) A staging plan for all construction phases;
 - (b) Location of any temporary construction works office and machinery storage area;
 - (c) Construction timeframes;
 - (d) Details of hours of construction;
 - (e) Intended access and routes of all construction vehicles in accordance with the approved TTMP;
 - (f) Vehicle and machinery exclusion zones;
 - (g) Measures and techniques to manage surface water runoff and to protect drainage lines and watercourses from sediment runoff from disturbed or under construction areas;
 - (h) Measures to protect sites of conservation or archaeological significance during construction;
 - (i) Measures to protect existing vegetation, which must be consistent with relevant measures set out in the Native Vegetation Management Plan approved in accordance with clause 6.8.1;
 - (j) Measures and techniques to avoid impacts on fauna;
 - (k) Measures and techniques to manage weeds;

- (I) Measures and techniques to manage dust;
- (m) Measures and techniques to manage erosion;
- (n) Location of a machinery and vehicle wash down area;
- (o) Management of litter, construction wastes and chemical storage;
- (p) Details of where construction personnel shall park;
- (q) Phone numbers of on-site personnel or other supervisory staff to be contactable in the event of issues arising on site;
- (r) The removal of works, buildings and staging areas on completion of the construction phase;
- (s) Methods of ensuring all contractors are informed of the requirements of the plan and persons responsible for ensuring the plan is adhered to.

6.8. Native Vegetation Management Plan

- 6.8.1. Before the removal of any native vegetation associated with the Project Infrastructure can begin, a Native Vegetation Management Plan must be prepared to the satisfaction of and be approved by the Department of Environment, Land, Water and Planning. The plan must be:
 - (a) drawn to scale with a key, north point, dimensions and georeferences (such as VicGrid94 coordinates), that clearly shows:
 - the location and identification of the land affected by this Incorporated Document, including standard parcel identifiers for the affected and adjacent land;
 - (ii) the location and area of all native vegetation present on the Infrastructure Area, including large trees within patches and scattered trees to be removed; and
 - (iii) all areas of native vegetation to be retained on the Infrastructure Area, including patch native vegetation, large trees within patches and scattered trees within the immediate vicinity of all construction impact areas.
- 6.8.2. The Native Vegetation Management Plan must include:
 - (a) a master plan and detailed subplans that include current aerial photography
 of a scale that enables the responsible authority to locate and identify the
 native vegetation permitted to be removed and audit for compliance;
 - (b) a detailed description of the measures to be implemented to protect the native vegetation to be retained throughout the life of the Project Infrastructure, including decommissioning, and the person/s responsible for implementation

- and compliance. These measures must include the erection of a native vegetation protection fence around all native vegetation to be retained on the Infrastructure Area, including the tree protection zones of all native trees to be retained. All tree protection zones must comply with AS 4970-2009 Protection of Trees on Development Sites and be clearly marked as 'no go zones'.
- (c) an avoid and minimise statement, which must describe all efforts to avoid the removal of and minimise the impacts on the biodiversity and other values of native vegetation, and how these efforts focussed on areas of native vegetation that have the most value. The statement must include details that demonstrate the following:
 - Strategic level planning any regional or landscape scale strategic planning process that the site has been subject to that avoided and minimised impacts on native vegetation across a region or landscape;
 - Site level planning how the proposed use or development has been sited or designed to avoid and minimise impacts on native vegetation; and
 - That no feasible opportunities exist to further avoid and minimise impacts on native vegetation without undermining the key objectives of the proposal.
- 6.8.3. Where the removal of native vegetation is to create required defendable space and/or satisfy bushfire risk mitigation requirements under the Fire and Emergency Management Plan and/or the Bushfire Attack Level required for buildings and infrastructure associated with the use and development, a written statement explaining why the removal of native vegetation is necessary must be provided to the satisfaction of the Department of Environment, Land, Water and Planning. This statement must have regard to other available bushfire risk mitigation measures and must account for the impacts to native vegetation in the DELWP generated Native vegetation removal report and subsequent offset requirements.
- 6.8.4. Except with the written consent of the Department of Environment, Land, Water and Planning, the following is prohibited within the area of native vegetation to be retained on the Infrastructure Area and any tree or vegetation protection zone associated with the permitted use and/or development:
 - (a) vehicular or pedestrian access;
 - (a) trenching or soil excavation;
 - (b) storage or dumping of any soils, materials, equipment, vehicles, machinery or waste products;
 - (c) entry and exit pits for the provision of underground services; and

(d) any other actions or activities that may result in adverse impacts to native vegetation.

Native vegetation permitted to be removed, destroyed or lopped

- 6.8.5. The native vegetation permitted to be removed, destroyed or lopped under both this Incorporated Document and the approved work plan for the Project Area is [X.XXX] hectares of native vegetation, which is comprised of:
 - (a) [X.XXX] hectares of patch native vegetation including [XXX] large trees, with a strategic biodiversity value of [X.XXX];
 - (b) [XXX] scattered large trees; and
 - (c) [XXX] scattered small trees.

(NOTE: [XXX] for final quantities of impacts and offset requirements to be completed once the final DELWP generated Native vegetation removal report has been generated to the satisfaction of the Department of Environment, Land, Water and Planning).

6.8.6. The native vegetation permitted to be removed in accordance with clause 6.8.5 can be removed and offset in stages throughout the life of the Project Infrastructure and Project, subject to compliance with the Native Vegetation Management Plan (in the case of removal associated with the Project Infrastructure) and the mining licence and work plan conditions (for all other approved native vegetation removal associated with the Project).

Native vegetation offsets

- 6.8.7. To offset the removal of 1.964 hectares of native vegetation (including 1.595 ha of native vegetation patches and 11 large trees) for the Project Infrastructure, the following native vegetation offsets must be secured in accordance with *Guidelines for the removal, destruction or lopping of native vegetation* (DELWP 2017) before any native vegetation removal for the Project Infrastructure can begin:
 - (a) a general offset of 0.007 general habitat units located within the East or West Gippsland Catchment Management boundaries or East Gippsland municipal area with a minimum strategic biodiversity value of at least 0.576;
 - (b) 1.118 species habitat units for [ID# 500547] Thick-lip Spider-orchid, Caladenia tessellate;
 - (c) 1.777 species habitat units for [ID# 501084] Purple Diuris, Diuris punctata;
 - (d) 1.200 species habitat units for [ID# 501120] Bushy Hedgehog-grass, Echinopogon caespitosus var. caespitosus;
 - (e) 1.177 species habitat units for [ID# 501197] Rough-grain Love-grass, Eragrostis trachycarpa;

- (f) 1.200 species habitat units for [ID# 501711] Slender Violet-bush, Hybanthus monopetalus;
- (g) 1.200 species habitat units for [ID# 501889] Slender Wire-lily, *Laxmannia gracilis*;
- (h) 1.200 species habitat units for [ID# 502651] Golden Pomaderris, *Pomaderris* aurea:
- (i) 1.177 species habitat units for [ID# 503583] One-flower Early Nancy, *Wurmbea uniflora:*
- (j) 1.176 species habitat units for [ID# 504754] Forest Red-box, Eucalyptus polyanthemos subsp. longior
- (k) 0.044 species habitat units for [ID# 504850] Gaping Leek-orchid, *Prasophyllum correctum*; and
- (I) 1.177 species habitat units for [ID# 505786] Silky Kidney-weed, *Dichondra sp,* 1.

The offset(s) secured must also protect 11 large trees. (Subject to confirmation once all known impacts and offsets have been verified by DELWP, before gazettal of the Incorporated Document). If less than 1.964 hectares of native vegetation is removed, the offset amount required can be reduced by a corresponding amount.

- 6.8.8. Before any native vegetation is removed for the Project Infrastructure, evidence that the required amount of corresponding offsets have been secured must be provided to the satisfaction of the responsible authority and the Department of Environment, Land, Water and Planning. This evidence must be one or both of the following:
 - (a) an established first party offset site including a security agreement signed by both parties, and a management plan detailing the 10-year management actions and ongoing management of the site, and/or
 - (b) credit extract(s) allocated to the Infrastructure Area (Planning Scheme Amendment Number from the Native Vegetation Credit Register).
- 6.8.9. For the avoidance of doubt, any offsets required for the removal of native vegetation for the Project Infrastructure and the Project must be obtained at no cost to the Head, Transport for Victoria, even if the native vegetation is removed from road reserves.

Offset evidence

6.8.10. A copy of the offset evidence required for the removal of native vegetation associated with the Project Infrastructure will be endorsed by the responsible authority and form part of this Incorporated Document. Within 30 days of endorsement of the offset evidence, a copy of the endorsed offset evidence must be provided to Planning &

- Approvals at the Department of Environment, Land, Water and Planning Gippsland regional office via Gippsland.Planning@delwp.vic.gov.au.
- 6.8.11. Where the offset(s) include a first party offset, an annual offset site report must be provided to the responsible authority by the anniversary date of the execution of the relevant offset security agreement, for a period of 10 consecutive years and thereafter, at the reasonable request of a statutory authority.
- 6.8.12. Within 12 months of the completion of the Project Infrastructure, native vegetation removal and offset requirements can be reconciled with the written agreement of the responsible authority and the Department of Environment, Land, Water and Planning.

6.9. Fire and Emergency Management Plan

- 6.9.1. Prior to commencement of any use or development, a Fire and Emergency Management Plan must be prepared to the satisfaction of the Country Fire Authority, the responsible authority and the Department of Environment, Land, Water and Planning.
- 6.9.2. The Fire and Emergency Management Plan may be amended from time to time to the satisfaction of the Country Fire Authority, the responsible authority and the Department of Environment, Land, Water and Planning.
- 6.9.3. The plan must address all elements of the Project Infrastructure as relevant, having regard to the use and development of the Project Area. The plan must include:
 - (a) Procedures for vegetation management, fuel control and the provision of firefighting equipment during declared fire danger periods;
 - (b) Procedures for planned burns or other fuel reduction measures to reduce overall fuel hazard levels;
 - (c) Protocols to address periods of high fire danger, including Total Fire Ban days and Code Red days;
 - (d) Procedures for hot work permitting to reduce the potential for ignitions and suspension or shutdown of tasks which may cause ignition (such as site preparation works in vegetated areas) on days of elevated fire danger;
 - (e) Criteria for the provision of static water supply solely for firefighting purposes in respect of bushfires and fires associated with the Project and Project Infrastructure;
 - (f) Procedures for maintaining suppression equipment and plant to respond to spot fires;
 - (g) Minimum standards for access roads and tracks to allow access for firefighting vehicles;

- (h) Bushfire awareness and response procedures, including response to formal emergency alerts issued by authorities;
- (i) Detailed register of flammable substances held on site, including quantities of such substances;
- (j) Details of response roles at the mine site;
- (k) Details of the location, design and role of fire refuges;
- Specification of BAL ratings for any buildings and identification of defendable space;
- A program for monitoring the implementation of bushfire mitigation measures on an on-going basis;
- (n) Responsibility for, and frequency of, reviews of the plan;
- (o) A requirement for the operator to facilitate annual familiarisation visits to the site and explanation of emergency services procedures, for the Country Fire Authority, Rural Ambulance Victoria, East Gippsland Shire Council Emergency Management Committee and Victoria Police; and
- (p) A requirement for the plan to be reviewed annually, in consultation with the Country Fire Authority, the responsible authority and the Department of Environment, Land, Water and Planning, and amended as necessary, based on the outcomes of that consultation.

6.10. <u>Decommissioning Plan</u>

- 6.10.1. No less than five years prior to closure, a Decommissioning Plan must be prepared to the satisfaction of the responsible authority and, in relation to the items in clause 6.10.2(c), (d), (f), (g), to the satisfaction of the Head, Transport for Victoria.
- 6.10.2. The Decommissioning Plan plan must address all elements of the Project Infrastructure within the Infrastructure Area. The Decommissioning Plan plan must include, as appropriate:
 - (a) The standard of remediation, being at a minimum the restoration of land to a standard suitable for uses previously capable of being undertaken on the land and to a soil quality of equal quality than previously existed on each site;
 - (b) Demolition and removal of all buildings, except in accordance with clause 6.10.4;
 - (c) Remediation of bores, roads and removal of all infrastructure, except in accordance with clause 6.10.4;
 - (d) A staging plan for all remediation phases;

- (e) Location of any temporary construction works office and machinery storage area;
- (f) Remediation timeframes;
- (g) Intended access and routes of all remediation vehicles;
- (h) Vehicle and machinery exclusion zones;
- (i) Measures and techniques to manage surface water runoff and to protect drainage lines and watercourses from sediment runoff from disturbed or under remediation areas;
- (j) Measures to protect sites of conservation or archaeological significance during remediation;
- (k) Measure to protect vegetation, which must be consistent with relevant measures set out in the Native Vegetation Management Plan approved in accordance with clause 6.8.1;
- (I) Measures and techniques to manage weeds;
- (m) Measures and techniques to manage dust;
- (n) Measures and techniques to manage erosion;
- (o) Location of a machinery and vehicle wash down area;
- (p) Management of litter, remediation, wastes and chemical storage;
- (q) Details of where remediation personnel shall park;
- (r) Phone numbers of on-site personnel or other supervisory staff to be contactable in the event of issues arising on site;
- (s) The removal of works, buildings, and staging areas on completion of the remediation phase; and
- (t) Methods of ensuring all contractors are informed of the requirements of the plan and persons responsible for ensuring the plan is adhered to.
- 6.10.3. The Decommissioning Plan may be amended from time to time to the satisfaction of the responsible authority, and in relation to traffic and transport on or associated with declared roads, to the satisfaction of the Responsible Road Authority.
- 6.10.4. Buildings, bores, roads and other infrastructure (excluding dams on gullies or creeks) need not be demolished or removed if:
 - (a) The landowner on which the infrastructure is present requests that the infrastructure not be demolished or removed; and
 - (b) The responsible authority and the Head, Transport for Victoria approves that request in writing.

6.10.5. Upon completion of the mining in the Project Area, the Decommissioning Plan must be implemented.

7. INDEPENDENT TECHNICAL REVIEWER

- 7.1. Prior to submission of any plan required by the Incorporated Document for approval or the granting of any application for a statutory authority an Independent Technical Reviewer must be established.
- 7.2. The Independent Technical Reviewer will be the same as that established under the Work Plan for the Project and operate under the same Terms of Reference.
- 7.3. Any plan or sub plan required under this Incorporated Document must be provided to the Independent Technical Reviewer for advice in accordance with the Terms of Reference in clause 7.2.

8. AVAILABILITY OF APPROVED PLANS AND DOCUMENTS

- 8.1. The current version of any approved plans and documents must be publicly available on a clearly identified Project website from date of approval and must remain available on such website for at least five years after the use and development (including any rehabilitation / decommissioning) of the Infrastructure Area ceases.
- 8.2. Material in an approved plan may be redacted in the publicly available plan if the inclusion of the material would:
 - 8.2.1. disclose personal information not necessary for the functioning of the plan; or
 - 8.2.2. disclose commercially sensitive information.

9. EXPIRY

- 9.1. The specific controls in this Incorporated Document expire if the development and use is not started within four years of the approval date.
- 9.2. The use and development of the Infrastructure Area authorised by these controls must be completed within 25 20 years of the commencement of the Project. If the use and development is not completed within 25 20 years, any use and development of the Infrastructure Area for the purposes of the Project Infrastructure must cease other than the use and development of the Infrastructure Area for the purposes of implementing an approved Decommissioning Plan, Fire and Emergency Management Plan or Native Vegetation Management Plan.
- 9.3. If the Infrastructure Area ceases to be used for the purposes of the Project Infrastructure for a continuous period of two years, or for two or more periods which together total two years in any period of three years, any use and development of the Infrastructure Area for the purposes of the Project Infrastructure must cease other than the use and development of the Infrastructure Area for the purposes of implementing an approved Decommissioning Plan.

- 9.4. For the avoidance of doubt, the Infrastructure Area does not cease to be used for the purposes of the Project Infrastructure merely because the Project is in care and maintenance.
- 9.5. If the Project is in care and maintenance for a period of four two or more years, the responsible authority must may serve on the holder of Mining Licence [xxxx] a notice requiring the licence holder to demonstrate in writing and to the satisfaction of the responsible authority that the Project is likely to exit care and maintenance in the next 12 months.
- 9.6. If notice is given in accordance with clause 9.5, then:
 - 9.6.1. If the licence holder does not provide a written response within 3 months of the service of the notice, then any use and development of the Infrastructure Area for the purposes of the Project Infrastructure must cease other than the use and development of the Infrastructure Area for the purposes of implementing an approved Decommissioning Plan, Fire and Emergency Management Plan or Native Vegetation Management Plan, which must be implemented as relevant:
 - 9.6.2. If the licence holder provides a written response to the notice and the responsible authority is not satisfied that the Project is likely to exit care and maintenance in the next 12 months, then any use and development of the Infrastructure Area for the purposes of the Project Infrastructure must cease other than the use and development of the Infrastructure Area for the purposes of implementing an approved Decommissioning Plan; or
 - 9.6.3. If the licence holder provides a written response and the responsible authority is satisfied that the Project is likely to exit care and maintenance in the next 12 months, the use and development of the Infrastructure Area for the purposes of the Project Infrastructure may continue in accordance with the controls in this Incorporated Document.
- 9.7. If, 12 months after the service of a notice under clause 9.5, the Project remains in care and maintenance, the responsible authority must may serve a further notice in accordance with clause 9.5.
- 9.8. This control expires upon the completion of any use and development required to implement the Decommissioning Plan, Fire and Emergency Management Plan or Native Vegetation Management Plan.
