- Boroondara C293 implements the recommendations of the Kew Heritage Gap Study (2017) to introduce the Heritage Overlay to 20 individual heritage places, nine heritage precincts and six heritage precinct extensions on an interim basis.
- Manningham C122 corrects errors and anomalies in the Manningham Planning Scheme by rezoning land, applying and deleting various overlay provisions.
