- [Boroondara C289](#) alters the planning scheme maps to the Heritage Overlay so that the Boroondara Planning Scheme is consistent with the Victorian Heritage Register.
- [Casey C261 case](#) gives effect to the *Cardinia Creek South Infrastructure Contributions Plan, March 2019* and makes associated changes to the Casey Planning Scheme.
- [Greater Geelong C386ggee](#) rezones part of the land at 65 Creamery Road, Bell Post Hill, from Farming Zone to Special Use Zone Schedule 15.
- [Hobsons Bay C125hbay](#) corrects references to the Hobsons Bay Heritage Study by replacing *Hobsons Bay Heritage Study Amended 2014* with *Hobsons Bay Heritage Study Amended 2017* at Clause 21.06 and Clause 22.01.
- [Kingston C159](#) rezones 1136-1138 Nepean Highway, Highett from Residential Growth Zone (Schedule 1) to Residential Growth Zone (Schedule 2).
- [Melton C200](#) implements the recommendations of the *Municipal Strategic Rewrite Background Report June 2017*.
- [Mitchell C127](#) amends the Schedule to Clause 72.01 to make the Minister for Planning the responsible authority for land described as Reserve No.1 PS824074A. 44 Kelly Street, Beveridge (the Kelly House).
- [Surf Coast C118](#) rezones part of the land at 40 Coombes Road, Torquay from Farming Zone to Industrial 3 Zone to facilitate Stage 5 of the West Coast Business Park.

- [Yarra C225](#) incorporates the site-specific control *351-353 Church Street, Richmond – Incorporated Document, February 2019* to allow for the use of land for the purposes of a residential aged care facility.
