### APPROVED

- [VC136](#) introduces state-wide planning requirements for apartment developments.

### EXHIBITIONS

- [Greater Shepparton C199](#) proposes to amend Schedule 4 to the Special Use Zone, Clauses 21.04, 21.05, 21.08 and 21.09 to implement the findings of the *Goulburn Valley Harness and Greyhound Racing Precinct Feasibility Study and Master Plan, July 2016*, include it as a reference document and strengthen the policy guidance for Investigation areas where an investigation area study has been completed.
- [Indigo C073](#) proposes to implement recommendations of the *Rutherglen Rural Living Study April 2016* by rezoning approximately 280 hectares north of Rutherglen to Rural Activity Zone; rezoning approximately 40 hectares to Low Density Residential Zone and applying Development Plan Overlay (Schedule 3); and rezoning the Carlyle Bushland Reserve to Public Conservation and Resource Zone to reflect its status as Crown land managed to protect natural values.
