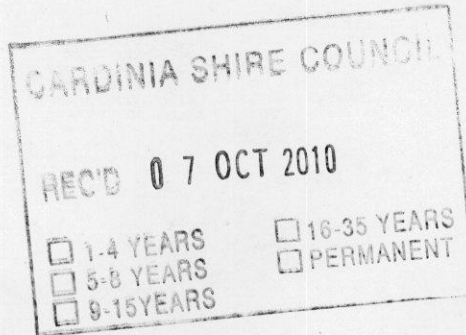

EVALUATION OF CULTURAL HERITAGE MANAGEMENT PLAN 11147: CARDINIA MOTOR RECREATION & EDUCATION PARK, PAKENHAM

I refer to your application, received on 31 August 2010, for approval of a cultural heritage management plan (management plan) for the Cardinia Motor Recreation & Education Park, Pakenham.

This management plan meets the standards prescribed for the purposes of s.53 and s.61 of the *Aboriginal Heritage Act 2006* (the Act), and is in the approved format. Therefore, acting under authority delegated to me by the Secretary, Department of Planning and Community Development and pursuant to section 65(2) of the Act, I approve the Cardinia Motor Recreation & Education Park, Pakenham, management plan and attach a notice of approval for that purpose.

The sponsor of an approved management plan must, within 14 days after the approval of the plan, give to the Secretary in the approved form, all assessment documentation relating to Aboriginal cultural heritage prepared or obtained in the course of the conduct of the assessment for the plan pursuant to section 67(1) of the Act.

Assessment documentation includes a hard copy and PDF of the management plan (with the approval notice/s inserted after the title page); VAHR forms not yet lodged; Archaeological Survey and Excavation Attributes forms; relevant Photographs; and Shapefiles of the activity area, ground survey areas, subsurface testing or excavation pits or transects, and the extent of Aboriginal Places recorded.
