DIGITISATION OF ALL PLANNING SCHEMES COMPLETE

The gazettal of amendment GC130 represents the completion of the DELWP project to migrate all 82 Victorian planning schemes from MS Word documents into the Amendment Tracking System (ATS). All planning authorities can now draft amendments to planning schemes using the ATS system. Please note that local provision templates are now contained in ATS and new Amendments must be drafted using the ATS system before submitting to the department for authorisation.

- [GC130](#) makes administrative, format and technical changes to the Boroondara, Melbourne, Moreland, Stonnington, Wyndham and Yarra Ranges Planning schemes to support the publishing of these planning schemes from the Amendment Tracking System (ATS). The Amendment also makes style and format changes to bulleted lists in two schedules of the Design and Development Overlay in the Maribyrnong planning scheme.
