

Upcoming consultation activities for all VMFRP projects

Consultation Plan Addendum

Last updated May 2025 (revision 6.0)

This is the addendum to the four consultation plans developed by the Victorian Murray Floodplain Restoration Project (VMFRP) to guide engagement during the environment assessment process.

The VMFRP will restore Murray River floodplains at ecologically significant sites across north-east Victoria. The sites are being assessed through either an Environment Effects Statement (EES) or an Environment Report (ER). Project sites have been divided into four zones for the assessment process:

The four project zones have separate consultation plans reflecting the different engagement needs at each of these locations. This centralised addendum is designed to make it easier for the community to see project-level activities alongside site-specific activities.

The four consultation plans and this addendum are considered live documents that are subject to change and will be updated as needed during the project consultation process. The consultation plans for active ER East and EES West assessment packages have recently been updated and are available on both the VMFRP website and the VMFRP-specific Victorian Department of Transport and Planning webpages.

With the Central EES and Central ER packages already progressed through public exhibition phases and assessed, the focus of consultation efforts now settles on activities to support the active ER East and EES West assessment packages.

The addendum provides a schedule of the VMFRP's proposed engagement activities from March 2025 until the end of 2025. An updated addendum will supersede this document in early 2026 with detail focussed on the commencement of the Public Exhibition of ER East and EES West.
