- 6. Ensuring that our people are suitably trained to carry out their roles in a competent and professional manner;
- 7. Promoting the health & wellness of our people by identifying and controlling workplace related health risks, and encouraging employees to be proactive about their health through supportive activities and communication;
- 8. Ensuring an open safety culture, openly communicating health and safety related information throughout the business, industry bodies and any other relevant parties;
- 9. Ensuring that competent contractors are selected with high health and safety expectations established for their work specialism;
- 10. Ensuring that measures to deal with all practicably foreseeable emergency situations are suitable and sufficient;
- 11. Ensuring that KPI's are agreed and implemented to ensure continuous improvement across our business;
- 12. Being clear that we will treat health, like safety across our business.
