APPROVALS

- [Brimbank C202brim](#) applies the Heritage Overlay to the Grand Junction and Matthew's Hill Precinct, Sunshine on an interim basis until 27 March 2020.
- [Cardinia C237card](#) seeks to amend various provisions of the Scheme to correct mapping anomalies, delete redundant controls and correct ordinance errors.
- [Frankston C124fran](#) implements the *Frankston Metropolitan Activity Centre Structure Plan, May 2018* (FMAC Plan) to the peripheral areas of the Frankston city.
- [Greater Dandenong C202gdan](#) deletes a redundant Public Acquisition Overlay from part of land at 2-8 Pickett Street, Dandenong.
- [Macedon Ranges C118macr](#) implements the recommendations of the *Gisborne and Kyneton Heritage Study*, December 2018 by applying the Heritage Overlay to 37 places in Gisborne, New Gisborne and Kyneton.
- [Manningham C117mann](#) amends Clause 21.07, Clause 21.16, Clause 22.19 and Clause 22.20 in the Scheme.
- [Maribyrnong C124mari](#) rezones the land known as 142 Ashley Street, Maidstone from Commercial 2 Zone to Mixed Use Zone.
- [Melbourne C359melb](#) extends the expiry date within Schedule 63 to Clause 43.02 Design and Development Overlay by two years until 30 September 2021.
- [Moonee Valley C208moon](#) extends interim mandatory maximum building height controls for the Moonee Ponds Activity Centre (Precincts 1-8) until 30 September 2020 by amending Schedule 1 to the Activity Centre Zone.
- [Stonnington C276ston](#) amends provisions of the Scheme affecting land in the Chapel Street Activity Centre to correct mapping anomalies, use and built form requirements, increase the area allocated for public open space and delete redundant controls.
- [Stonnington C298ston](#) extends the expiry date of the interim heritage overlay control for HO635 *Hawksburn Railway Station Precinct extension* to 31 March 2020.
- [Wellington C108well](#) alters the planning scheme maps and the Schedule to the Heritage Overlay so that the Scheme is consistent with the Victorian Heritage Register.
