LATROBE VALLEY DRAFT PRELIMINARY LAND USE VISION

DELWP has released a *Draft Preliminary Land Use Vision* as part of the mine rehabilitation investigations under the Latrobe Valley Regional Rehabilitation Strategy (LVRRS). It creates a land use framework for potential future land use opportunities in the Latrobe Valley, particularly around the three open-cut coal mines. The Preliminary Land Use Vision will inform the final LVRRS which is to be released by June 2020.
