# Echuca Moama Bridge Project

Environment Effects Statement (EES), Review of Environmental Factors (REF) and Preliminary Documentation

Written submissions on the Environment Effects Statement, Review of Environmental Factors and Preliminary Documentation are now invited. Submissions close at 5:00pm on Friday 9 October 2015

### The Project

VicRoads and Roads and Maritime Services New South Wales (NSW) propose to develop a new crossing of the Murray and Campaspe Rivers, including an elevated roadway and extensive bridging and/or culverts across the Murray and Campaspe River floodplains, and improvements to existing approach roads in Victoria and NSW. The new crossing connects the Murray Valley Highway at Echuca in Victoria with the Cobb Highway at Moama in New South Wales.

As the project affects both Victoria and NSW, environmental factors have been considered for both States.

#### **Environment Effects Statement**

The former Victorian Minister for Planning determined on 14 June 2013 that an Environment Effects Statement (EES) was required for the project under the *Environment Effects Act 1978*. The EES process will inform decision-making on the project under Victorian law

The EES has considered four options:

- The Mid West Option (the preferred alignment);
- The Mid West 2A Option;
- The Mid West 2B Option; and
- The 'no project' scenario.

### Draft amendment

The EES includes a draft planning scheme amendment known as Amendment C103 to the Campaspe Planning Scheme for the Mid West Option. This draft amendment would facilitate acquisition of private land and the construction of the Mid West Option without the need for a planning permit.

The public review of the EES provides the public with an opportunity to comment on the project and the draft amendment.

### **Review of Environmental Factors**

A Review of Environmental Factors (REF) has also been prepared under part 5 of the *Environmental Planning and Assessment Act 1979.* The REF documents all matters affecting or likely to affect the environment in NSW as a result of the proposal.

The REF has considered one option. The alignment in NSW is the same for the Mid West, Mid West 2A and Mid West 2B Options.

### **Preliminary Documentation**

Preliminary Documentation has been prepared and this notice is also published pursuant to Section 95A of the *Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)*. The proposed action, identified as a second Murray River crossing at Echuca-Moama based on the Mid West Option (EPBC 2013/6850), is to be developed by VicRoads and Roads and Maritime Services. The proposed action is a controlled action under the *EPBC Act*. The controlling provisions are Sections 18 and 18A (threatened species and ecological communities).

### EES Inquiry process (Vic. only)

A combined Inquiry and Advisory Committee (the Inquiry) will be appointed by the Minister for Planning under the *Environment Effects Act 1978* and the *Planning and Environment Act 1987* to consider the exhibited documents and public submissions relevant to Victoria.

The Inquiry will hold a Directions Hearing in the week commencing 27 October 2015 in Echuca. At this hearing, the Inquiry will establish the necessary arrangements and a timetable for the public hearings.

Public hearings are expected to begin the week commencing 16 November 2015 in Echuca. Requests to be heard by the Inquiry must be received prior to or at the Directions Hearing. All submitters who wish to present to the Inquiry are asked to note these arrangements and commence preparations in advance.
