### CHANGES TO PLANNING REGULATIONS

The Planning and Environment Amendment (Objectors Review Timing) Regulations 2018 were made by the Governor in Council on 13 June 2018 and come into effect on 1 July 2018.

The Regulations amend regulation 35 of the Planning and Environment Regulations 2015 to standardise the point at which the time an objector can apply for review starts. The date of the notice of the decision is the point that the counting of the days starts. The number of days has been increased from 21 days to 28 days to take account of the new starting point and the changes to delivery time by Australia Post.
