Viva Energy Gas Australia Pty Ltd (Viva Energy; the Proponent) (ABN 35 645 450 059) has prepared an Environment Effects Statement (EES) for the Viva Energy Gas Terminal Project (the project).

The EES, together with the draft Greater Geelong Planning Scheme amendment (PSA) C442ggee, the EPA development licence applications for the floating storage and regasification unit and the amendment to the Viva Energy refinery activities, and the pipeline licence application are now available for public comment.

This notice is provided pursuant to the Environment Effects Act 1978 (Vic) (EE Act), the Environment Protection and Biodiversity Conservation Act 1999 (Cth) (EPBC Act), the Pipelines Act 2005 (Vic) and the Environment Protection Act 2017 (Vic).

Written submissions can be made starting Monday 28 February 2022 and closing 11:59pm on Monday 11 April 2022.

Project Description

The project comprises the development of a gas terminal using a ship known as a floating storage and regasification unit (FSRU) at Refinery Pier in Corio Bay, adjacent to Viva Energy's Geelong Refinery. The project would bring natural gas from other parts of the country and overseas to meet an anticipated gas shortage in south-eastern Australia in coming years.

The key components of the project are:

- Extension of the existing Refinery Pier a new pier arm, new berth and ancillary pier infrastructure
- Localised dredging for the new berth and ship turning basin, and deposition of dredged sediment at the existing Point Wilson dredged material ground
- The FSRU continuously moored at the new berth, which would receive liquefied natural gas (LNG) from visiting LNG carriers, store and convert the LNG into natural gas when needed
- A treatment facility located within the Geelong Refinery site to check that the gas meets transmission system standards, where odorant and nitrogen (when required) is added
- A 7-kilometre pipeline to transfer the gas from the FSRU to the South West Pipeline connection point at Lara, comprising a 3-kilometre aboveground section and a 4-kilometre underground section

If the project gains all required approvals, construction is anticipated to begin early 2023 and finish in early to mid 2024.

EES Process

On 28 December 2020, the Victorian Minister for Planning determined that an EES is required for the project under the EE Act.

EPBC Act Process

On 21 January 2021, the delegate for the Commonwealth Minister for the Environment determined that the project is a 'controlled action' as it is likely to have a significant impact on Matters of National Environmental Significance (MNES), which are protected under the EPBC Act.

The Viva Energy Gas Terminal Project, Geelong (EPBC 2020/8838) controlled action is intended to be taken by Viva Energy. The relevant provisions for the controlled action are Ramsar wetlands (section 16 & section 17B), listed threatened species & communities (section 18 & section 18A), and listed migratory species (section 20 & section 20A).



The EES process is an accredited assessment process under the EPBC Act through a Bilateral Assessment Agreement that exists between the Commonwealth and State of Victoria. Therefore, this EES also considers MNES for the purposes of assessment of the controlled action under the EPBC Act. You can make a submission on the matters assessed for the purposes of the relevant provisions under the EPBC Act, by making a submission on the EES (see more information about making submissions on the EES below).

After considering the Victorian Minister for Planning's assessment under the EE Act, the Commonwealth Minister for the Environment will then make a separate decision as to whether to approve the controlled action application for the proposed project under the EPBC Act.



Planning Scheme Amendment

The draft PSA including an explanatory report and supporting documents has been prepared. The draft PSA is included as Attachment VII to the EES. The draft PSA seeks to apply the Specific Controls Overlay and an Incorporated Document to facilitate the use and development of land for a Gas Terminal. It also seeks to extend the area covered by the Greater Geelong Planning Scheme to include the extension to Refinery Pier and water to a distance of 110 metres from the Pier and to apply the Port Zone to the amended area.

EPA Development Licences

The EPA has received two applications for development licences under the Victorian Environment Protection Act 2017. One is from Viva Energy Gas Australia Pty Ltd for the FSRU component of the project and the other is from Viva Energy Refining Pty Ltd for the reuse and discharge of FSRU wastewater from the existing Viva Energy refinery.

Both these development licence applications are included as Attachment V to the EES.

Pipeline Licence Application

A pipeline licence is required under the *Pipelines Act 2005* (Vic) (Pipelines Act) for the construction and operation of the pipeline included in the project. The proposed pipeline was the subject of a Notice of Pipeline Corridor pursuant to section 27 Pipelines Act. An application was made to the Minister for Energy, Environment and Climate Change in February 2022. The application is included in the exhibited documents at Attachment VI to the EES.

Any person who may be affected by the grant of the pipeline licence may make a written submission to the Minister for Energy, Environment and Climate Change about the application for the licence by following the EES submission process below. All such submissions will also be treated as submissions on the EES.

How to Make a Submission

Submissions on the EES, draft PSA, EPA development licence applications and the pipeline licence application must be made in writing and be received by 11:59pm on Monday 11 April 2022.

Each submission is a public document and will be treated as a submission on the EES and on the other exhibited documents (draft PSA, EPA development licence applications and the pipeline licence application). Only one submission is needed to address all of your views about the project, its effects and the relevant documents.

Online submissions are preferred and can be lodged via the Victorian Government's engagement website https://engage.vic.gov.au/viva-gas-terminal-IAC

Where a submitter is unable to lodge a submission online, they must contact Planning Panels Victoria (PPV) through the DELWP Customer Call Centre on 136 186 (select option 6) and request a hardcopy submission coversheet. Each hardcopy submission must be accompanied by a coversheet issued by PPV for privacy reasons.

All submissions must state the name and address of the person making the submission. Petition responses will be treated as a single submission and only the first names from a petition submission will be registered and contacted.

Submissions will be treated as public documents and will be published on the Engage Victoria website. Do not include personal information in the body of your submission (such as your email address or phone number or photos of people, particularly children).

Your submission and your name will be made public.

The submission process is independently managed by PPV and any inquiries regarding the management of submissions and the Inquiry and Hearing process should be directed to PPV.

Inquiry and Advisory Committee Process

The Minister for Planning will appoint a joint Inquiry and Advisory Committee (IAC) under the EE Act and the *Planning and Environment Act 1987* to hold an inquiry into the project and its environmental effects. The IAC will review the public submissions, the EES, the draft PSA and the EPA development licence applications. It will consider the environmental effects of the project in accordance with the Terms of Reference issued by the Minister for Planning.

The IAC may also be appointed by the Minister for Energy, Environment and Climate Change as a panel under the Pipelines Act to consider written submissions and the pipeline licence application.

After the exhibition period, the IAC will hold a Directions Hearing, likely in the week commencing 2 May 2022 or the week commencing 9 May 2022, where the necessary arrangements and timetable for the public hearing will be established.

Further information about the Directions Hearing arrangements (including whether it will be held in person or conducted online by video conference) will be published on https://engage.vic.gov.au/viva-gasterminal-IAC when determined. The IAC will follow the health advice from the Victoria Government and the Chief Health Officer in making this decision.

The Public Hearing process will likely commence in the week beginning Monday 20 June 2022 and run for approximately 4 to 5 weeks (if required)

Members of the public and any other parties seeking to be heard at the public hearing are required to submit a written submission and indicate on the online submission form or hard copy submission coversheet that they would like to be heard at the hearing.
