e space is provided for a distance of metres around the building or to the property boundary whichever is the lesser and managed in e with the following:

- s must be short cropped and maintained during the declared fire danger period.
- aves and vegetation debris must be removed at regular intervals during the declared fire danger period.
- in 10 metres of a building, flammable objects must not be located close to the vulnerable parts of the building.
- is greater than 10 centimetres in height must not be placed within 3m of a window or glass feature of the building.
- bs must not be located under the canopy of trees.
- idual and clumps of shrubs must not exceed 5 sq. metres in area and must be separated by at least 5 metres.
- s must not overhang or touch any elements of the building.
- canopy of trees must be separated by at least 5 metres.
- e must be a clearance of at least 2 metres between the lowest tree branches and ground level.

ninimum of 10,000 litres of effective water supply for fire fighting purposes including:

- ocation of the CFA outlet, the occupier's outlet and the pipeline between the tank and the CFA outlet, and
- material of manufacture and nominal diameter of all piping and fittings.

er supply must be installed so that it meets the following requirements:

- static water supply must be stored in an above ground tank constructed of concrete or metal.
- static water supply must be provided with an outlet for the CFA (CFA outlet) that includes a 64 mm CFA 3 thread per inch male coupling.
- static water supply must also include an outlet which incorporates a ball or gate valve separate to the CFA outlet for use by the owner/occupier of the land.
- FA outlet must be:
 - Easily accessible by a firefighter in the event of a bushfire,
 - Clear of all vegetation for a distance of 1.5 metres,
- Setback from flammable objects (including timber fences and timber retaining walls) for a minimum distance of 1.5 metres,
- Located a minimum distance of 10 metres and no more than 60 metres from the building,
- Oriented horizontally.
- nternal diameter for the fitting connecting the tank to the pipeline must be equivalent to or greater than the internal diameter of the pipeline between the tank and re authority outlet.
- centreline of the CFA outlet must be:
 - A minimum of 300mm and maximum 600mm in height above the finished ground level and located below the level of the outlet on the tank.
- riser for the CFA outlet must be supported by a galvanised steel post at least 50mm x 50mm or equivalent which is concreted in the ground to a depth of at least
- mm British Standard Pipe (BSP) ball or gate valve must be provided at the CFA outlet to control the flow of water to the CFA coupling. Any other valves between FA outlet and the tank must be locked in the open position.
- CFA outlet must be easily identifiable from the entrance to the property or signage must be provided that meets the following requirements:
 - Has an arrow pointing to the location of the fire authority outlet,
 - Has dimensions of not less than 310mm high and 400mm long,
 - Is red in colour, with a blue reflective marker attached, and
 - Is labelled with a 'W' that is not less than 15cm high and 3cm thick.
- CFA outlet must include a fade-resistant or engraved sign that:
- Is fixed to the post supporting the fire authority outlet riser,
- Has a minimum height of at least 1.5m from the ground surface level, and
- Includes the words "FIRE WATER TANK OUTLET" in lettering that is a minimum of 50mm in height and white on a red background.
- e reflective disc at least 50mm in diameter must be attached to the post holding the sign. The blue reflective disk must be located immediately below the sign.
- elow-ground water pipes must be installed to provide at least the following cover below the finished surface:
- 300 mm for pipes subject to vehicle traffic,
- 75 mm for pipes under buildings or concrete slabs, and
- 225 mm for all other locations.
