

PUBLIC NOTICE - INVITATION TO COMMENT
ALBERTON WIND FARM, ALBERTON WEST, VICTORIA

Draft Assessment Documentation (EPBC 2017/7854)
Public comment period: 29/08/2018 to 27/09/2018

Synergy Wind Pty Ltd proposes to build and operate a Wind Farm comprising 34 Turbines with a maximum blade tip height of 200m and Removal of 1.195 hectares of native vegetation and sixteen (16) scattered trees associated supporting infrastructure, including access roads, and underground cables to link the proposed turbines in the Alberton area, Victoria.

The project or action (EPBC 2017/7854) requires approval under the Commonwealth *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act). The relevant controlling provisions for matters of national environmental significance (MNES) are: sections 18 and 18A (listed threatened species and communities), sections 20 & section 20A (listed migratory species) and section 16 & section 17B (the ecological character of a declared Ramsar wetland).

Assessment of the project's (action) impacts on MNES are being assessed by the State of Victoria through an accredited process under Schedule 1 (item 2.1 (f)) of the Bilateral (Assessment) Agreement between the Commonwealth and the State under the EPBC Act. The proponent's draft Assessment Documentation, being exhibited as part of the planning permit process, describes the likely impacts on MNES as well as feasible alternatives, mitigation measures and proposed offsets to address relevant impacts on MNES for the Alberton Wind Farm.

Interested persons are invited to submit comments on this draft Assessment Documentation and the project's impacts on MNES by 5:00pm on 27 September 2018.
