STOCKMAN BASE METALS PROJECT

ENVIRONMENT EFFECTS STATEMENT DRAFT AMENDMENT TO THE EAST GIPPSLAND PLANNING SCHEME

Written submissions on the exhibited documents are now invited. Submissions close at 5.00pm on 8 May, 2014

Stockman Project Pty Ltd, a wholly owned subsidiary of Independence Group NL, proposes to develop the Stockman mining and processing project in East Gippsland, Victoria. The project will produce copper and zinc concentrates over a projected nine year operating life.

The Victorian Minister for Planning determined on 16 August 2010 that an Environment Effects Statement (EES) was required for the proposal under the *Environment Effects Act 1978* due to the potential for significant environmental effects. The EES process will inform decision-making on the proposal under Victorian law.

An EES has been prepared in accordance with Scoping Requirements issued for the project, and provides an assessment of the potential environmental, social and economic impacts of the project.

The EES documentation includes a draft Amendment to the East Gippsland Planning Scheme for project infrastructure proposed outside the Stockman mining lease. Stockman intends to request a Ministerial amendment to the planning scheme under section 20(4) of the *Planning and Environment Act 1987*. If accepted, there would be no further opportunity for public comment on the amendment beyond the current EES process.

A draft Work Plan required for project approval under the *Mineral Resources (Sustainable Development) Act 1990* is included with the EES documentation

The project (EPBC 2010/5717) also requires approval under the Commonwealth *Environment Protection and Biodiversity Conservation Act* 1999 (EPBC Act. The Victorian EES process will inform the EPBC Act approval decision.

Inquiry Process

An Inquiry will be appointed by the Minister for Planning under the *Environment Effects Act 1978* to consider the exhibited documents and public submissions. The Inquiry may also be appointed as an Advisory Committee under the *Planning and Environment Act 1987* to consider the draft Planning Scheme Amendment. Information on the Inquiry process and timetable for the hearings will be published on the Internet at www.dtpli.vic.gov.au/environmental-assessment as it becomes available.

The Inquiry will hold a Directions Hearing on 20 May 2014 in Bairnsdale to establish necessary arrangements and timetable for the public hearing. Public hearings are expected to begin in week commencing 23 June 2014. Requests to be heard by the Inquiry must be received by the end of the Directions Hearing. All submitters who wish to present to the Inquiry are asked to note these arrangements and commence preparations in advance.
