APPROVAL

- [Ballarat C193](#) applies the heritage overlay to elements of 'Arranmore' 80 Howe Street, Miners Rest, amends Clauses 21.10, Clause 43.01 Schedule and Clause 61.03 Schedule to insert a new reference document and new planning scheme map 5HO.
- [Ballarat C205](#) corrects errors in the description of affected land in the schedules to Clauses 52.01, 52.03 and 61.01 and in the *Ballarat Station Precinct Redevelopment Incorporated Document, August 2016*.
- [Boroondara C257](#) extends the expiry date of interim heritage controls which apply to 22B Essex Road, Surrey Hills (HO654) until 30 June 2017.
- [Brimbank C191](#) facilitates the delivery of the level crossing removal at Melton Highway, Sydenham.
- [GC58](#) - Macedon Ranges and Port Phillip - changes planning provisions for sites that have been transferred to the Victorian Government - 601 Mount Macedon Road, Mount Macedon, 131 Waterfalls Road, Mount Macedon, and 31-35 Albert Road Drive, Albert Park.
- [Greater Geelong C347](#) applies to all land in the Farming Zone and Rural Conservation Zone and amends the Local Planning Policy Framework at Clauses 21.07 and 22.06, and introduces a new Clause 22.64.
- [Latrobe C087 Part 2](#) implements key parts of the *Traralgon Growth Area Review Framework (2013)* and the *Traralgon West Structure Plan (2013)* relating to the Maryvale Australian Paper Mill, by amending Clauses 21.04, 21.05, 21.06 and 21.07 of the Municipal Strategic Statement.
