## Summary of consultation with Gunaikurnai Land and Waters Aboriginal Corporation (GLaWAC)

In November 2018, GLaWAC was one of the first groups of stakeholders advised of the project. Since then further information has been supplied on a regular basis, including provision of copies of the Pipeline Consultation plan and maps of the pipeline routes and options. This information was also provided to GLaWAC's Native Title legal representative.

Recent face-to-face communications with GLaWAC's RAP manager has included information on upcoming heritage survey involvement. They were recently advised:

The project area has been refined and now focusses of a single route for the first half of the alignment from the shore crossing and then 3 route options from there.

The Project had engaged its heritage advisors who will undertake desktop assessment, develop a predictive model for the study area and scope the likely standard and complex assessments required.
