Mt Buller Water Storage Project

As the mountain's local Water Supply Authority, the Mt Buller and Mt Stirling Alpine Resort Management Board (RMB) is responsible for providing adequate potable water to the village and its residents. The need for greater water storage capacity is key to addressing supply issues that currently limit resort operations.

In the "white season" there is an increasing demand for water to supply snowmaking operations to address variations in natural snowfall. In the warmer months, adequate water supply is required for "green season" visitation and to provide an essential water source for firefighting at the resort and in surrounding forested areas of the Central Highlands. The RMB has identified that on-mountain water storage is insufficient to supply both peak winter and summer demands. The RMB has also identified that insufficient water storage is a major impediment to climate change adaptation planning.

Victorian alpine tourism also makes a significant contribution to the overall visitor economy. In the winter season of 2015, close to 1.4 million people visited an alpine resort in Victoria, generating \$671 million in Gross State Product and 5,942 FTE jobs. Mt Buller accounted for approximately 40% of this economic activity. Construction of the proposed water storage asset would also enable Mt Buller to further enhance its contribution to the regional economy through increased tourism and private investment.

An adequate on-mountain water supply will become more important as the predicted impacts of climate change are realised. The Mt Buller Water Storage Facility is a cornerstone project for the resort's adaptive response to a challenging and uncertain future environment.

Planning Permit | Mt Buller Water Storage Project

I write in relation to the planning application lodged by Mt Buller Mt Stirling Resort Management for the development of the Mt Buller Water Storage Project.

As you may be aware, Mt Buller and the surrounding area, is subject to extreme fire risk, being located within an Alpine Resort and surrounded by National Park. Furthermore, the topography and limited access and egress creates additional complications for fire-fighting and can impact evacuation.

The area has a long history of bushfire, including significant fires in 2002, 2006-2007 and more recently in 2013-2014. The CFA, to support local and broader regional fire-fighting efforts, have previously utilised Mt Buller's current water storage which also happens to be the mountains only storage of potable water.

The Mt Buller Water Storage Project is of critical importance to the ongoing safety of Mt Buller and the wider region. This project will assist with the provision of adequate levels of potable water for residents and visitors to the Resort, water supply for snow making activity as well as being able to have adequate reserves of water for emergency purposes including fire fighting.

An on mountain water storage would provide a significant resource of water, which could provide gravity fed supply of water for fire-fighting. As the water would be gravity fed, it would remove the need to rely on electricity to pump the water, which is significant as electricity cannot be relied upon during fire.



I write in support of the planning application lodged by Mt Buller Mt Stirling Resort Management for the development of the Mt Buller Water Storage Project.

The Tourism & Transport Forum Australia (TTF) is the peak national body for the tourism, transport and aviation sectors across Australia. We are a CEO forum representing some of the leading institutions and corporations in the Australian visitor economy. Our membership spans accommodation and transport providers, airlines and airports, restaurants and retailers, business and major events organisers, property developers, investors and land managers, amusement and cultural attractions, and professional services. TTF utilises its expertise and networks to develop and advocate public policy for the sustainable long-term growth of the visitor economy.

The economic engine of winter contributed \$647 million to Gross State Product (GSP) and 6,000 jobs to Victoria's economy in 2012. Snow security is increasingly a challenge, with the growing reliance on snow-making reinforcing the need for government investment in providing basic underground infrastructure, such as water and power, in partnership with the lift companies that provide snow guns and other equipment.

TTF supports the construction of an additional new water storage facility to provide a higher level of security of water resources available to the Mt Buller Resort. TTF has also outlined its support for this project in its pre-Budget submission to the 2016-17 Victorian State Budget, enclosed for your information.

Mt Buller Resort is one of the key drivers of the local and regional economy, and contributes significantly to the region's tourism identity as a year-round destination. Not only does Mt Buller capture up to 40 per cent of the visitors to Victoria's alpine resorts, the highest visitation of the Victorian resorts, equating to over \$200 million of GSP; but it also generates an estimated \$89 million, or 21 per cent, of the Mansfield Shire Gross Regional Product (based on 2011 figures).


A larger and more reliable on-mountain water storage facility is required to secure the existing snowmaking program, essential to maintaining skiable terrain and overall product. Such a storage facility is also a proactive response to improve resilience to increased weather variability as well as provide adequate reserves of water for emergency purposes related to firefighting.

A secure water supply is also required for Mt Buller to maintain a reliable potable water supply with the benefit of developing summertime offerings and increase visitation during the 'green season', supporting all-year visitation. While the 'green season' is in its infancy, it is still worth \$94 million to GSP and supports 1,000 jobs in Victoria.

The Mt Buller water storage facility is key to improving the mountain's sustainability through maintaining snowmaking capacity, which is critical to creating wider economic and employment benefits to the regional Victorian economy. TTF supports the planning application lodged by Mt Buller Mt Stirling Resort Management for the development of the Mt Buller Water Storage Project.
